I stressed that staying in school and obtaining an education is the key to success.

The most rewarding experiences have been the visitations I have made to the homes of several elders within the community. Spending time with them has made me realize they have a wealth of knowledge to share if only we take it in. Their "smiles" and "thanks" will forever remain in my fond memories as Teen Miss Lumbee.

This year as Teen Miss Lumbee has definitely been one of growth in knowledge and a better understanding of myself and others. Knowing that if I have touched one heart I have made a difference, and therefore, my year as Teen Miss Lumbee has been a successful one.

As my reign as Teen Miss Lumbee comes to an end, I would like to express my deepest gratitude and appreciation to all who have helped me throughout this year. Without the support of you and my family, especially, such a successful year would not have been possible.

I leave each of you with this – "the experience is not what life gives you, but better yet, what you make of it!"
